

SPECTRO CLOUD SOFTWARE END USER LICENSE AGREEMENT

YOU SHOULD CAREFULLY READ THE FOLLOWING TERMS AND CONDITIONS BEFORE USING THIS PRODUCT. BY INSTALLING THE SOFTWARE, USING THE SOFTWARE, AND/OR ACKNOWLEDGING ACCEPTANCE OF THIS AGREEMENT IN ANY OTHER WAY YOU ARE CONSENTING TO BE BOUND BY AND ARE BECOMING A PARTY TO THIS AGREEMENT.

This Software End User License Agreement (the "EULA" or "Agreement") sets forth the terms and conditions of your use of the accompanying software (the "Software").

1. Definitions.

- (a) **"Authorized Users"** means individuals (including non-human devices, such as applications or services) who are authorized by you to use the Software.
- (b) **"you"** means you, the end user
- (c) **"EULA"** or **"Agreement"** means this Spectro Cloud Software End User License Agreement
- (d) **"Documentation"** means Licensor's user guides and other end user documentation for the applicable Software, as may be updated by Licensor from time to time.
- (e) **"License"** has the meaning in Section 2 below.
- (f) **"Licensor"** means Spectro Cloud, Inc. and its subsidiaries and affiliates.
- (g) **"Software"** means the software and services you are licensing under this EULA
- (h) **"Subscription Term"** means the period of the License and your authorized use as described in section 7 below.

2. **License Grant.** Licensor hereby grants to you a non-exclusive, non-assignable, non-transferable, limited license (the, "License") to use the Software and related Documentation solely for the intended purposes of the Software as set forth in the Documentation, according to the provisions contained herein and subject to payment of applicable license fees. You are not permitted to lease, rent, distribute, sell, or sublicense the Software or any rights therein. The License granted is limited in number to the extent specified when purchased. Further, no license is granted to you in the human readable code of the Software (i.e., source code). Except as provided below, this Agreement

does not grant you any rights to patents, copyrights, trade secrets, trademarks, or any other rights in the Software and Documentation. During the Subscription Term, you may allow your Authorized Users to access and use the Service in accordance with the Documentation, solely for Customer's business purposes.

You agree that you have no right, power, or authority to make any modifications to or unauthorized copies of the Software and may only use the software in the manner permitted by Licensor as described in the Documentation. You may reproduce and provide one (1) copy of the Software and Documentation for each device, computer, node, or workstation on which the Software is installed. Otherwise, the Software and Documentation may be copied only as essential for backup or archive purposes. You must reproduce and include all copyright notices and any other proprietary rights notices appearing on the Software and Documentation on any copies that you make.

3. **No Assignment; No Transfer.** You agree not to transfer or assign the Software and/or this Agreement to another party without the prior written consent of Licensor. If such consent is given and you transfer or assign the Software and/or this Agreement, then you must at the same time either transfer any copies of the Software and Documentation to the same party, or destroy or return to Licensor any such materials not transferred. Except as set forth above, you may not transfer or assign the Software or rights under this Agreement.
4. **No Modification; No Reverse Engineering.** You agree not to modify, translate, reverse engineer, decompile, disassemble, or create derivative works of the Software or assist someone in performing such prohibited acts.
5. **Law; Import/Export Restrictions.** You are responsible for compliance with all applicable laws, regulations, rules, and legal requirements. You agree not to import, export, or re-export the Software or any Documentation (or any copies thereof), or any products utilizing the Software or any Documentation except as authorized by the laws of the United States and/or the jurisdiction in which the License was obtained. For example, but without limitation, into United States embargoed countries or territories, to anyone on the United States Treasury Department's Specially Designated National List, or to anyone on the United States Department of Commerce Denied Persons List or Entity List. You further represent and warrant that you are not located in any prohibited country or on any prohibited list, and you agree that you will not use the Software or Documentation for any purposes prohibited by United States law, including, without limitation, the development, design, manufacture, or production of nuclear, missile, chemical, or biological weapons.

6. **Title.** You agree that Licensor owns and holds all right, title, and interest to the Software and any Documentation, and all subsequent copies thereof regardless of the form or media. Furthermore, all title, ownership rights, and intellectual property rights in the Software and any Documentation shall remain with Licensor, including all corrections, enhancements, or other modifications made thereto. The Software and any Documentation are protected by copyright and other intellectual property laws and by international treaties. All rights not expressly granted to You under this Agreement are reserved by Licensor.
7. **Subscription Term and Termination.** This License will begin from the date that you first use the software. This License shall expire upon the termination or expiration of any agreement, order, or other arrangement giving rise to your purchase of the License, if the License is not earlier terminated. You may terminate this License at any time by (i) deleting all instances of the Software and Documentation, and destroying the Software and any Documentation together with all copies and merged portions in any form, and (ii) certifying to Licensor, in writing, that all copies of the Software and Documentation have been deleted or destroyed. Your License for the Software will also terminate immediately if you fail to comply with any term or condition of this Agreement, file for bankruptcy, become insolvent, or are placed in receivership. Upon such termination, you agree to immediately (i) stop all use of the Software and Documentation, (ii) delete and/or destroy the Software and Documentation, together with all copies thereof, and (iii) certify to Licensor, in writing, that all copies of the Software and Documentation have been deleted or destroyed. You agree that you will not be entitled to a refund of any applicable license fee upon early termination of this Agreement.
8. **Governing Law.** The laws of the State of California shall govern the construction of this Agreement and you agree to be subject to personal jurisdiction in the State of California for the purposes of enforcing the provisions of this Agreement.
9. **Limited Warranty.** Licensor warrants that for the Subscription Term of the License, the Software, if operated as directed, will substantially achieve the functionality described in any Documentation. Licensor does not warrant, however, that your use of the Software will be uninterrupted or error-free.

Licensor's sole liability for any breach of this warranty shall be, in Licensor's sole discretion (i) to replace your defective media or Software, or (ii) to advise you how to achieve substantially the same functionality with the Software as described in any Documentation through a procedure different from that set forth in any Documentation, or (iii) if the above remedies are impracticable, to refund the License fee you paid for the Software. Repaired, corrected, or replaced Software and

Documentation shall be covered by this limited warranty for the period remaining under the warranty that covered the original Software.

Only if you notify Licensor of your problem with the Software during the applicable warranty period and provide physical evidence of the date you purchased or obtained the License to the Software will Licensor be obligated to honor this warranty. Licensor will use reasonable commercial efforts to resolve any such problem within a reasonable time of being such notification.

If any modifications are made to the Software by you during the warranty period or if you violate the terms of this Agreement, then this warranty shall immediately terminate and be void. This warranty shall not apply if the Software is used on or in conjunction with hardware or software other than the unmodified version of hardware and software with which the Software was purchased with or designed to be used as described in the Documentation.

THIS IS A LIMITED WARRANTY, AND THE WARRANTY SET FORTH IN THIS AGREEMENT IS THE ONLY WARRANTY MADE BY LICENSOR. LICENSOR MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT OF THIRD PARTIES' RIGHTS. TO THE FULL EXTENT PERMITTED BY LAW, THE DURATION OF STATUTORILY REQUIRED WARRANTIES, IF ANY, SHALL BE LIMITED TO THE ABOVE LIMITED WARRANTY PERIOD. MOREOVER, IN NO EVENT WILL WARRANTIES PROVIDED BY LAW, IF ANY, APPLY UNLESS THEY ARE REQUIRED TO APPLY BY STATUTE NOTWITHSTANDING THEIR EXCLUSION BY CONTRACT. NO DEALER, AGENT, OR EMPLOYEE OF LICENSOR IS AUTHORIZED TO MAKE ANY MODIFICATIONS, EXTENSIONS, OR ADDITIONS TO THIS LIMITED WARRANTY. THE ENTIRE RISK ARISING OUT OF USE OR PERFORMANCE OF THE SOFTWARE REMAINS WITH YOU.

10. **Limitation of Remedies.** UNDER NO CIRCUMSTANCES AND UNDER NO LEGAL THEORY SHALL LICENSOR,, OR ITS SUPPLIERS OR RESELLERS, BE LIABLE TO YOU OR ANY OTHER PERSON FOR ANY INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OF ANY CHARACTER INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF GOODWILL, LOST PROFITS, BUSINESS INTERRUPTIONS, WORK STOPPAGE, COMPUTER FAILURE OR MALFUNCTION, OR ANY AND ALL OTHER PERSONAL OR COMMERCIAL DAMAGES OR LOSSES ARISING FROM THE USE OR INABILITY TO USE THE PROGRAMS (WHETHER OR NOT DUE TO ANY DEFECTS THEREIN). IN NO EVENT WILL LICENSOR BE LIABLE FOR ANY DAMAGES EVEN IF LICENSOR SHALL HAVE BEEN INFORMED OF THE POSSIBILITY OF SUCH DAMAGES OR SUCH DAMAGES WERE REASONABLY FORESEEABLE, OR FOR ANY CLAIM BY ANY OTHER PARTY. THIS LIMITATION OF LIABILITY SHALL NOT APPLY TO LIABILITY FOR DEATH OR PERSONAL INJURY RESULTING FROM LICENSOR'S GROSS NEGLIGENCE OR INTENTIONAL MISCONDUCT TO THE EXTENT APPLICABLE LAW PROHIBITS SUCH LIMITATION. IN NO EVENT SHALL LICENSOR'S LIABILITY EXCEED THE PURCHASE PRICE PAID BY YOU FOR THE SOFTWARE.

11. **Indemnification.** You agree to defend, indemnify, and hold harmless Licensor, its suppliers and its resellers from and against all liabilities, costs, damages, and expenses (including settlement costs and reasonable attorneys' fees) arising from any claims from anybody that result from or relate to your use, reproduction, or distribution of the Software, or your breach of any representation, warranty, or obligation under this Agreement.

12. **Severability.** In the event any provision of this Agreement is found to be invalid, illegal, or unenforceable, the validity, legality, and enforceability of any of the remaining provisions shall not in any way be affected or impaired.

13. **Public Sector End User Provisions**

(a) **End User Definition for Public Sector.** A Public Sector End User that is governed by these additional provisions is any End User that is

- (i) a government, legislature, judiciary, or other decision making body, instrumentality, department, or agency at any level, national, local, municipal, county, or otherwise and any entities managed, controlled, or owned by government interests;
- (ii) public organizations or foundations, both domestic and international, of any kind including political parties, political organizations, or political candidates;
- (iii) The Software and Documentation are "Commercial Items", as that term is defined at 48 C.F.R. §2.101, consisting of "Commercial Computer Software" and "Commercial Computer Software Documentation", as such terms are used in 48 C.F.R. §12.212 or 48 C.F.R. §227.7202, as applicable. Consistent with 48 C.F.R. §12.212 or 48 C.F.R. §227.7202-1 through 227.7202-4, as applicable, the Commercial Computer Software and Commercial Computer Software Documentation are being licensed to United States Government end users (a) only as Commercial Items and (b) with only those rights as are granted to all other end users pursuant to the terms and conditions herein. Unpublished-rights are reserved under the copyright laws of the United States.

14. **Entire Agreement.** You further agree that this Agreement is the complete and exclusive statement of the agreement between you and Licensor, and supersedes all proposals or prior agreements, oral or written, and all other communications between you and Licensor relating to the subject matter of this agreement. This Agreement may only be modified by a written agreement signed by both you and an authorized representative of Licensor.

15. **Acknowledgment.** By downloading, installing, or using any part of this Software, you indicate that you have read this Agreement, understand it, and agree to be bound by its terms and conditions.
16. **Force Majeure.** Licensor shall not be liable hereunder for any failure or delay in the performance of its obligations under this Agreement if such failure or delay is on account of causes beyond its control, including, but not limited to, labor disputes, civil commotion, war, fires, floods, inclement weather, governmental regulations or controls, public health related orders or quarantines, casualty, government authority, strikes, or acts of God, in which event Licensor shall be excused from its obligations for the period of the delay and for a reasonable time thereafter.
17. **Waiver.** The failure or delay by Licensor to require performance of any provision of this Agreement does not constitute a waiver. All waivers by Licensor must be provided in writing and signed by Licensor in each instance, and a waiver in one instance does not constitute a waiver in any subsequent instance.
